Sandra Barbree opened the meeting at 6:02 p.m.

On a motion by Amy Carrales, seconded by Rita Cundieff, with all present voting "Aye", the Charter Review Commission unanimously approved the Charter Review Commission meeting minutes from October 3, 2019.

Discuss the review of Charter sections 10 through the end of the Charter.

Assistant City Manager Stephanie Russell, City Attorney Chris Duncan, City Council Liaison Brooks Bass and the Charter Review Members discussed Sections 10-the end of the Charter.

- Sections 10.01-10.05 Brooks Bass said that he feels that these sections are fine and do not need change. Chris Duncan said that he has these sections marked, he believes that the thought was to change Public Utility to clarify what we mean by "Public Utility" and needs to speak with Mr. Kelty.
- **10.06 Grant not to be Exclusive** Assistant Stephanie Russell said that this needs to be revised or removed completely.
- 10.07 Consent of Property Owners No recommendations.
- 10.08 Extensions No recommendations
- 10.09 Other Conditions No recommendations.
- **10.10 Accounts of Municipally-Owned Utilities** No recommendations.
- 10.11 Sales of Water, Sewer and Any Other Services No recommendations.
- 11.01 Publicity of Records This needs to be changed to "In Accordance with State Law."
- **11.011 Selection of Newspaper for Publication** Chris Duncan said in this section he recommends removing "Or permitted."
- **11.02 Personal Interest** Chris Duncan and Stephanie Russell recommends changing the language to mirror State Law in this section.
- 11.03 Drilling Operations Chris Duncan recommends the removal of the first sentence in this section.
- **11.04 Nepotism** No recommendations.
- 11.05 Provisions Relating to Assignment, Execution and Garnishment Chris Duncan, Stephanie Russell and Brooks Bass said that this may need to be revised after compared to State Law.
- 11.06 City Not Required to Give Security or Executive Bond Chris Duncan said that he will make sure that this complies with State Law.
- 11.07 Special Provisions Covering Damage Suits Chris Duncan said that this must comply with State Law. The present Charter states that within thirty days. State Law says it must happen within six months. Stephanie Russell said to clean up, or completely remove.
- **11.08 Severability Clause** It is recommended that this section title be corrected from "Separability" to "Severability."
