It was decided that flyers will be made, meeting to be held downtown at the fountain on 2/23 at 10:00 a.m., begin advertising on 3/2, begin Green Market on 4/19, continue every Saturday from 8 til noon and Tuesday from 4 to 7 p.m. It will be
