#### 3. Citizens Comments

Bobby Bass presented to Board a copy of a procedural complaint against the City Manager and the Main Street Director in regards to a Design Committee meeting to be held on Wednesday, the 13<sup>th</sup>. It was stated in this letter that meeting was cancelled and that Jeff is now the Design Committee. Bobby stated that at no time during the previous meeting was the current design committee removed or the City Manager appointed as a committee of one by the board. He felt the Main Street Director has violated the rules of the Main Street Program. Bobby also stated that he felt the Main Street Board as well as the City Council should investigate this abuse of power.

Board then discuss out of order item 11 on the agenda--- the Summertimes Blues Festival.. Discussion is included in item 11 below.

4. Discussion concerning the Blessing of the Fleet and action if needed.

This event is going to be held Memorial Day Weekend with Rock the River along with the Beach Bash on Monday. Sandra Barbree reported that there would be a parade of boats, Rock the River event, and The Blessing of the Fleet. Bands will provide entertainment. Also a Kingfish Tournament will be hosted by the Freeport Main Street. Tournament dates are May 28<sup>th</sup> and 29<sup>th</sup> at the Freeport Marina & Boat Ramp. Entry fee is \$150.00 per boat with a 4 man crew. Extra entries will be \$50.00 per person. Entry fee will include trophies, meals, prize money, and weigh master fee. There will be a \$6,500 payout contingent on a 100 boat entry.

The Blessing of Fleet will begin at 6:00 p.m. with a Captain's Dinner to follow weigh-in on Sunday. Estimated budget for this portion of event is \$600.00. Other expenses will come out of money collected from event.

The Bryan Beach Bash will be from 9 a.m. to 9 p.m. Activities include live music, volleyball, horseshoes, washers, cowboy golf, sand castle contest, swim suit contest, and watermelon eating contest. Estimate budget for this event is \$3,000.

All trophies costs and prize money will be generated thru registration fees. Total Budget is \$6,600.00.

5. Discussion concerning the Flap Jack Run and action if needed.

Lalo Garcia gave update on the Flap Jack Run. He reported that he received bids on the T-Shirts. Shirts will cost \$8.35 each and we will be ordering 200 shirts. Cost will be \$1,770. Marjorie Clark made motion with second by Sandra Loeza for purchase of T-Shirts. Motion approved by all present. Marty DeLeon made motion with second by Marjorie Clark to pay up to \$75.00 for the purchase of award medals. Motion approved by all present. Marjorie Clark made motion with second by Marty DeLeon to pay the individual who will be doing the race timing a fee of \$150 or \$1 per person whichever is greater. Motion approved by all present. Lalo mentioned also that volunteers are still needed.

Discussion concerning the acquisition of another building for the museum and action if needed.

We have purchased the adjoining building to museum and have a one year option to purchase the other available building next to museum.

7. Discussion concerning the Rock the River Festival and action if needed.

Rock the River will be held at Municipal Park on May 28<sup>th</sup> from 12 p.m. to 12 a.m. Activities include live music, carnival, vendors, car shows, freak/sideshow, bike rally and stunt riders. Estimated budget for this event is \$3,000. Main Street will received 20% of the take on carnival. Vendor booths will be \$50.00. We will receive 60% split for our part on beer sales.
