Discuss/consider whether or not Mr. Eric Hayes should be allowed to erect a 14' x 24' LED sign at the entrance of his property located on the East side of Brazosport Boulevard (State Highway 288), being Lots Ninety-Two (92) and Ninety-Three (93), BCIC Division 14, A. Calvit League, Abstract Forty-Nine (49) and J. F. Fields Survey, Abstract Sixty-Two (62).
