WHEREAS, the City of Freeport, Texas, (hereinafter sometimes "the City") is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, Article 9 of the Home Rule Charter of the City requires the adoption of an annual budget; and,

WHEREAS, under Section 102.001(b) of the Local Government Code, because the City has a city manager form of government, the city manager is the budget officer of the City municipality and under Section 102.002 of said Code and Chapter 9 of said Charter, the city manager is required to prepare a proposed annual budget for the municipality and, under Section 102.03(a) of said Code and Chapter 9 of said Charter, is required to file the same with the city secretary before the 30th day before the date the governing body of the municipality makes its tax levy for the fiscal year; and,

WHEREAS, under Chapter 9 of said Charter, the governing body of the municipality is required to adopt a budget not later than fifteen (15) days prior to the beginning of the fiscal year; and,

WHEREAS, under Section 102.006(a) and (b) of the Local Government Code and Chapter 9 of said Charter, the governing body of the municipality is required to conduct a public hearing on such proposed annual budget; and

WHEREAS, under Section 102.006(c) of the Local Government Code and Chapter 9 of said Charter, public notice of the date, time and location of such hearing must be given, under Section 102.0065(c) and Section 102.011 of said Code the provisions of said Charter control as to the method of giving such notice and under Chapter 9 of said Charter said notice must be published at least 15 days before the date of such hearing in the official newspaper of the City; and,

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

SECTION ONE (1) - Findings of Fact

In connection with the adoption of the 2014-2015 ANNUAL BUDGET, the City Council hereby makes the following findings:

- (1) The proposed budget for the City's Fiscal Year 2014-2015, a copy of which is attached hereto as Exhibit "A", is the result of several workshop meetings, each of which were conducted in accordance with and notice of each of which was given in the manner required by the Texas Open Meetings Act, now codified as Chapter 551 of the Government Code.
- (2) On the 29th day of July, 2014, the City Manager filed with the City Secretary the original of such proposed annual budget.
- (3) A public hearing on such proposed budget was held on the 8th day of September, 2014, beginning at 6:00 p.m., in the Municipal Courtroom of the Police and Courts Building of the City of Freeport, Texas, located therein at 430 Brazosport Boulevard.
- (4) Notice of such hearing was published in the Brazosport Facts, the official newspaper of the City, on the 22nd day of August, 2014.
- (5) This ordinance is being adopted at the conclusion of such hearing and on the same date as the date on which such hearing was held.
- (6) The contingent appropriations in such budget do not exceed three percent (3%) of the total budget appropriations.
- (7) The estimated expenditures of the General Fund and Debt Service Fund stated in such budget do not exceed total estimated resources of each find.

SECTION TWO (2) - Proposed Annual Budget Adopted; Appropriations

The PROPOSED ANNUAL BUDGET for the City's FISCAL YEAR 2014-2015, in its complete form, as heretofore filed with the City Secretary, and with any changes thereto made following such workshop meetings and the public hearing mentioned above, attached hereto and made a part hereof as Exhibit MA., is hereby ADOPTED; and the several amounts set forth therein as proposed expenditures are hereby APPROPRIATED to and for the objects and purposes therein specified.

THIS BUDGET WILL RAISE MORE TOTAL PROPERTY TAXES THAN LAST YEAR'S BUDGET BY \$90,201.00 OR 4.01%, AND OF THAT AMOUNT, \$24,710.00 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR.

<u>SECTION THREE (3) - Filing of Copies</u>

A copy of this ordinance and of the attached complete copy of such budget, attached hereto as Exhibit M., shall be filed with the City Secretary of the City of Freeport, Texas and shall be maintained with the official records of the City. Certified copies thereof shall be filed by the City Secretary with the County Clerk of Brazoria County, Texas and the office of the State Comptroller of Public Accounts for the State of Texas.

SECTION FOUR (4) - Severance Clause

Any section or provision of this ordinance found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

SECTION FIVE (5) - Effective Dates

This ordinance shall be effective from and after its passage and the annual budget adopted hereby shall be in effect for the Fiscal Year of the City beginning October 1, 2014, and ending September 30, 2015.

ORDINANCE NO. 2014-2072

AN ORDINANCE OF THE CITY OF FREEPORT, TEXAS, CONTAINING A PREAMBLE; AMENDING SECTIONS 52.15 AND 52.16 OF THE CODE OF ORDINANCE OF SAID CITY TO INCREASE THE RATES FOR WATER AND SEWER AND WATER ONLY SERVICES SET FORTH THEREIN FOR SERVICE FURNISHED ON OR AFTER OCTOBER 1, 2014, TO INDUSTRIAL FACILITIES, OFFICES AND OTHER COMMERCIAL ESTABLISHMENTS, RESIDENCES AND CUSTOMERS LOCATED INSIDE AND OUTSIDE THE CORPORATE LIMITS OF THE CITY; CONTAINING A SAVINGS CLAUSE; CONTAINING A SEVERANCE CLAUSE; AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT FROM AND AFTER OCTOBER 1, 2014.

WHEREAS, the City of Freeport, Texas (athe City.), is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, Chapter 552 of the Local Government Code and Section 2.01 and 2.02 and Items (n) and (u) of Section 3.07 of the Home Rule Charter of the City authorize the City Council thereof to adopt the provisions of this Ordinance; and,

WHEREAS, the City Council of the City has determined and does here now declare that the adoption of this ordinance is necessary to the health, safety and general welfare of the inhabitants of said City and persons using it utility system.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

First, Division (A)(1) and (2) of Section 52.15 of the Code of Ordinances of the City of Freeport, Texas, is hereby amended to read as follows:

■(A) The city shall charge for the furnishing of sewer service to customers within the corporate limits of the city and shall charge each customer as follows:

(1) In the case of sewer service furnished to single-family residences and multi-family residences within the city:

0 gal to 2,000 gal.

\$13.40 (minimum charge)

3,000 gal. to 12,000 gal. \$4.62 per 1,000 gal.

13,000 gal. and up

\$6.70 per 1,000 gal.

(2) In the case of sewer service furnished to all other customers, including but not being limited to industrial facilities, offices and other commercial establishments:

0 gal. to 2,000 gal. of water \$13.40 (minimum charge)

3,000 to 12,000 gal. of water \$7.22 per 1,000 gal.

13,000 Up gal. of water 9.53 per 1,000 gal.

Second, Division (A) of Section 52.16 of the Code of Ordinances of the City of Freeport, Texas, is hereby amended to read as follows:

- ■(A) The city shall furnish water service to customers within the corporate limits of the city and shall charge each customer as follows:
- (1) In the case of water furnished to single-family residences and multi-family residences located within the city:

0 gal. to 2,000 gal. \$14.74 (minimum rate)

3,000 gal. to 12,000 gal. \$5.092 per 1,000 gal.

All over 13,000 gal. \$6.70 per 1,000 gal.

(2) In the case of water furnished to all other customers, including but not being limited to industrial facilities, offices and other commercial establishments located within the city:

0 gal. to 2,000 gal.

\$15.48 (minimum rate)

3,000 gal to 12,000 gal.

\$7.223 per 1,000 gal

13,000 gal. and up \$9.53 per 1,000 gal.

(B) The city shall furnish water service to customers outside the corporate limits of the city and shall charge each customer passibllows:

0 gal. to 2,000 gal.

3,000 gal. and up

\$10.83 per 1,000 gal.

(-C) The city shall furnish water only service to customers inside the corporate limits of the city and shall charge each customer as follows:

0 gal. to 2,000 gal.

3,000 gal. to 12,000 gal. \$7.63 per 1,000 gal.

13,000 gal. and up

\$10.05 per 1,000 gal.

Third, nothing contained in this ordinance shall cause any rights heretofore vested to be altered, affected or impaired in any way and all such rights may be hereafter enforced as if this ordinance had not been adopted.

Fourth, in the event any section or provision of this ordinance is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

Fifth, this ordinance shall take effect and be in force from and after October 5, 2014.

As we discussed in previous budget hearings and discussions, we propose an employee benefits package increase related to retiree health insurance. The reasoning behind such request is employee retention and recruiting. In our current business market and with the new multi-billion dollars of investment and overwhelming demand that will be placed upon the employment market the ability to compete, recruit and retain employees during the next five to six years is going to become very competitive. This retiree health insurance plan coupled with our proposed employee pay plan will provide us with competitive abilities to retain and attract new employees.

The plan we discussed and propose is a separate insurance plan our current insurance provider (TML) offers for retiree health insurance. This proposal in no way will affect or increase the rates of our fulltime employee health plans. The retiree plan is separate and limited in value.

The plan as proposed is limited in value and can only be realized once the following provisions are met:

- An employee must meet or exceed our TMRS retirement conditions; which are: 20 years of service or reaching the age of 60; and
- > An employee must have a minimum of eight (8) years of contiguous service with the City of Freeport and meet the TMRS qualifications of retirement

This plan enables a retiree that meets the aforementioned prerequisites a maximum amount of \$750.00 per month towards their retiree health insurance plan. Any amount over the \$750.00 will be the responsibility of the retiree. Note: this plan only applies to a retiree up to the age of 65.

This plan will allow us to retain current employees and recruit other qualified talented candidates. The plan itself will not cost the City any money upon implementation, but only once an employee meets or exceeds the prerequisites listed above. This plan does not affect any employee who retired before the implementation of the retiree health insurance plan.

ORDINANCE NO. 2014-2073

AN ORDINANCE AUTHORIZING THE OFFERING OF HEALTH BENEFITS COVERAGE TO City of Freeport RETIREES; REPEALING ALL ORDINANCES IN CONFLICT; PROVIDING AN OPEN MEETINGS CLAUSE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Freeport desires to provide health benefits coverage to its retirees;

WHEREAS, TML MultiState Intergovernmental Employee Benefits Pool (IEBP) is a health risk pool established pursuant to Texas Local Government Code Chapter 172, Texas Government Code Chapter 791, and the Texas Trust Code to provide health benefits coverage for employees and retirees and dependents of employees and retirees, of Texas political subdivisions under an Interlocal agreement;

WHEREAS, the City of Freeport is currently offering health benefits coverage through IEBP pursuant to Interlocal agreement and Chapter 172 of the Texas Local Government Code, both of which would allow the extension of benefits to retirees of the City of Freeport;

WHEREAS, the City of Freeport desires to provide health benefits coverage to its retirees through IEBP and that the cost for such coverage be paid for by the City of Freeport to a maximum of \$750 per month; Any additional amount will be the responsibility of the retiree.

WHEREAS, the City of Freeport desires to select a plan of benefits for its retirees to be provided by IEBP; and

WHEREAS, providing retiree coverage under IEBP Interlocal Agreement is in the best interest of the *City* of *Freeport*, its retirees, and the public generally;

BE IT ORDAINED BY THE CITY COUNCIL OF THE City of Freeport, Texas THAT:

SECTION 1: The foregoing recitals are incorporated into this Ordinance as findings of fact.

SECTION 2: The *City of Freeport* hereby elects to provide health benefits coverage to its retirees through IEBP under the Pool's Interlocal Agreement.

SECTION 3: The *City of Freeport* hereby adopts the following definition of "retiree" for purposes of this ordinance:

An employee who is under 60 years of age and has been covered by TMRS (Texas Municipal Retirement System) for at least 20 years, or an employee who is 60 years of age or older and has been covered by TMRS for at least 5 years. The employee must also work for the City of Freeport for a period of eight continuous years and meet the definition of retiree for purposes of this ordinance.

SECTION 4: The *City of Freeport* hereby adopts the following benefit plans to be provided to its retirees through IEBP: **Pg. 839**

• The medical plan adopted for retirees which are provided for in the IEBP Pre Sixty-Five Retiree Pool Plans.

SECTION 5: The Interlocal Agreement in effect between the City of <u>Freeport</u> and IEBP provides that the Board of Trustees may adopt rules and regulations which may amend this plan in the future. Other coverage's will be as established annually by the TML MultiState Intergovernmental Employee Benefits Pool Board of Trustees.

SECTION 6: This ordinance will only apply to individuals retiring after its effective date or to employees, which retired under a previous ordinance. For individuals retiring after the effective date of this ordinance to qualify they must enroll for this coverage within thirty (30) days of their retirement. This benefit will terminate when the retiree attains age 65.

SECTION 7: This ordinance may be repealed or modified at any time, but will remain in effect for any employee retiring while it is in effect.

SECTION 8: The City Secretary is hereby ordered to enter a copy of this Ordinance in the City minutes.

SECTION 9: All existing *City of Freeport* ordinances in conflict with the provisions of this Ordinance are repealed to the extent of the conflict.

SECTION 10: It is hereby officially found and determined that the meeting at which this Ordinance was considered was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.

SECTION 11: This Ordinance shall be effective immediately upon its passage.
