AN ORDINANCE OF THE CITY OF FREEPORT, TEXAS, CONTAINING A PREAMBLE; AMENDING DIVISION (D) OF SECTION 50.04 OF THE CODE OF ORDINANCES OF SAID CITY TO SPECIFY THE TYPE OF CART THAT MAY BE USED AND ADDITIONAL RULES DEALING WITH THE PLACEMENT OF WASTE FOR COLLECTION; AMENDING DIVISION (A) OF SECTION 50.06 OF SAID CODE OF ORDINANCES TO PROVIDE THAT THE COST OF EACH ADDITIONAL RESIDENTIAL SIZE CART AT THE SAME FAMILY UNIT SHALL BE \$14.37 PER MONTH; AMENDING DIVISION (B) OF SECTION 50.06 TO PROVIDE THAT THE CHARGE FOR RESIDENTIAL SIZE CARTS AND THE COLLECTION AND DISPOSAL OF SOLID WASTE STORED IN SUCH CARTS AT EACH COMMERCIAL OR BUSINESS LOCATION WITHIN THE CITY SHALL BE \$22.78 PER MONTH PER CART AND THE CHARGE FOR ADDITIONAL CARTS AT THE SAME LOCATION SHALL BE \$14.37 EACH PER MONTH; CONTAINING SAVINGS CLAUSES; CONTAINING A SEVERANCE CLAUSE: AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND ADOPTION.

WHEREAS, the City of Freeport, Texas, (hereinafter sometimes "the City") is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, Sections 51.072, 54.001 and 54.004 of the Local Government Code, Chapter 361 of the Health and Safety Code and Sections 2.01, 2.02, 3.07(k) and (o) and 10.04(e) of the Home Rule Charter of the City authorize the City Council thereof to adopt the provisions of this Ordinance; and,

whereas, the City Council of the City has determined and does here now declare that the adoption of this ordinance is necessary to the health, safety and general welfare of the inhabitants of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

First, Division (D) of Section 50.04 of the Code of Ordinances of the City is hereby amended to read as follows:

- ■(D) Additional Rules for the Placement of Waste for Collection:
- (1) Refuse, rubbish, trash and untreated wood may not be placed in

the easement or right-of-way of any street. All untreated wood products must be cut into pieces of not more than five feet in length.

- (2) Only Waste Connections polycarts may be used.
- (3) Polycarts must be placed so that there is a three foot clearance on all sides.
- (4) No more than two cubic yards of debris of any kind may be placed at the street. If more than two cubic yards is placed at the street, the resident will be charged for the excess on the water bill at the rate per yard defined by the City's contract with Waste Connections. Any debris of any kind placed at the street between Wednesday and Friday will be picked up and the water account for the property from which it is removed will be billed 100% of the cost of the removal at the rate defined by the contract with Waste Connections.
- (5) Tree limbs and debris must be cut to five foot lengths.
- (6) Stumps and bagged debris must weigh less than fifty pounds.
- (7) Property owners are responsible for any outstanding balance for all charges on a water account for their property, whether such account is in the owners name or the name of a tenant or lessee. No water account will be opened at that property until such balance is paid in full.

Second, Section 50.06 of said Code is hereby amended to read as follows:

■The following charges and rates shall be made and collected by the city for solid waste collection:

- (A) Residential: \$22.78 per month for a residential size cart and the collection and disposal of solid waste in such cart at each family unit within the city and \$14.37 per month for each additional cart at the same family unit. FAMILY UNIT shall be construed to mean any one-family residence or apartment, or any other one-family dwelling.
- (B) Commercial or business: \$22.78 per cart for the collection and disposal of solid waste stored in each residential size container at a commercial or business location within the city. The charge for each additional container at such location shall be \$14.37 per month.

Third, this ordinance is cumulative of and in addition to all other ordinances of the City on the same subject and all such ordinances are hereby expressly saved from repeal.

Fourth, where this ordinance and another ordinance conflict or overlap, this ordinance shall prevail.

Fifth, no offense committed and no fine, forfeiture or penalty incurred prior to the effective date of this ordinance is to be affected by the adoption of this ordinance, but the punishment for any offense committed and the recovery of any fines or forfeitures incurred prior to such date shall take place as if this ordinance had not been adopted.

Sixth, if any section or provision of this ordinance is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

Seventh, this ordinance shall take effect and be in force from and after its passage and adoption.

Centralizing the monitoring at the Police Station 24x7 allows the Police Department to have access to and manage those surveillance systems remotely and to alert officers when necessary.
- Bridge & Roadway Ingress/Egress Points
 - o The five listed entry/exit points support the majority of the traffic coming in and out of the city.
