BE IT ORDAINED AND ORDERED, RESPECTIVELY, BY THE CITY COUNCIL AND MAYOR OF THE CITY OF FREEPORT, BRAZORIA COUNTY, TEXAS:

SECTION ONE -- Scope of Ordinance

A RESOLUTION OF THE CITY OF FREEPORT, TEXAS, CONTAINING A PREAMBLE; MAKING FINDINGS OF FACT; ACCEPTING THE ALTERNATE BID OF AND AUTHORIZING THE MAYOR AND CITY SECRETARY TO EXECUTE AND ATTEST, RESPECTIVELY, AND THE MAYOR TO ACKNOWLEDGE AND DELIVER A SPECIAL WARRANTY DEED CONVEYING THE FEE TITLE TO 0.764 ACRES OF LAND, MORE OR LESS, OUT OF THE STEPHEN F. AUSTIN SURVEY, ABSTRACT 32 AND THE STEPHEN F. AUSTIN SURVEY ABSTRACT 33, BOTH IN BRAZORIA COUNTY, TEXAS, AND DESCRIBED IN EXHIBIT "A" ATTACHED HERETO, TO THE GARY J. WOODRING, HE BEING THE SOLE BIDDER THEREFOR; CONTAINING A SEVERANCE CLAUSE; PROVIDING THAT THIS RESOLUTION SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND ADOPTION; AND PROVIDING THAT THE ORIGINAL OF THIS RESOLUTION SHALL BE MAINTAINED BY THE CITY SECRETARY IN THE PERMANENT RECORDS OF SAID CITY.

WHEREAS, the City of Freeport, Texas, ("the City") is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, Section 2.01 of the Home Rule Charter of the City authorizes it to sell any real property owned by the City; and,

WHEREAS, Subsection (a) of Section 272.001 requires that before a municipality may sell any land or exchange it for other land, notice to the general public, including a description of the land and its location and the procedure by which sealed bids to purchase such land or offers to exchange such land may be submitted, must be published on two separate dates in a newspaper, if any, of general circulation published in the county in which such land is located and that such sale or exchange cannot be made until after the 14th day after the date of the second publication; and,

WHEREAS, the City Council of the City, having determined to sell the hereinafter described land owned by the City, did cause public notice thereof to be published twice in the Brazosport Facts, a newspaper of general circulation in Brazoria County, Texas, where such land is located, to-wit, on February 12, 2012, and February 19, 2012; and,

WHEREAS, the only bidder therefor was GARY J. WOODRING, who offered a bid of \$61,780.01 and an alternate bid for \$38,758.00 coupled with an agreement to immediately develop such land with bulkheading the waterfront and building a slightly elevated traditional style residence (not a beach house look) with a completed structure improvement value of \$300,000.00, to be completed by October, 2013, without applying for the City's tax abatement for new construction, both such bids having been received within the time specified in such notice;

WHEREAS, the City Council of the City has determined and does here now declare that accepting such alternate bid will be in the best interest of the inhabitants of the City, considering the amount of value that will be added to the tax roll of the City by Cctober, 2013, if there is no tax abatement is made or granted.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

First, the City Council of the City of Freeport, Texas, finds that the fact recited in the preamble hereof are true.

Second, the City Council of the City hereby accepts the alterative bid of the said Gary J. Woodring therefor and authorizes the Mayor and City Secretary thereof to execute and attest, respectively, and the Mayor to acknowledge and, upon the written acceptance of such deed by the said Gary J. Woodring and the receipt by the City's Director of Finance from the said Gary J. Woodring of the sum of \$38,758.00, deliver to the said Gary J. Woodring a deed containing a special warranty and conveying the fee title to the real property owned by the City and described in Exhibit "A" attached hereto and made a part hereof, on condition subsequent that the said Gary J. Woodring will immediately develop such land with bulkheading the waterfront and building a slightly elevated traditional style residence (not a beach house look) with a completed structure improvement value of at least \$300,000.00, to be completed by October 1, 2013, and without applying for the City's tax exemption for newly constructed residences.

Third, in the event any section or provision of this resolution is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this resolution and such remaining sections and provisions shall remain in full force and effect.

Fourth, this resolution shall take effect and be in force from and after its passage and adoption.

Fifth, the original of this resolution, after execution and attestation, shall be maintained by the City Secretary in the permanent records of the City.




