There being a quorum with the Planning Commission, Mayor Norma Garcia opened the Joint Public Hearing at 6:20 p.m.

Edward Garcia Chairperson for the Planning Commission stated that the Planning Commission had discussed the new classification of W-4 Marina district. They had not received any negative comments. The Planning Commission recommended a new classification of W-4 Marina District to wit:

Beginning at the intersection of the north ROW line of West Second Street, at its intersection with the east ROW line of Cherry Street; thence north to the northern ROW line of the Freeport Townsite Levee; thence east to the extension of the eastern property line of Tract 1A, Thomas McKinney Survey, Abstract 87, Brazoria County, Texas; thence north along that extended line to the centerline of the Old Brazos River Channel; thence along the center line of that Channel east to the extension of the western property line of Tract B1A, S. F. Austin Survey, Abstract 28, Brazoria County, Texas; thence south along that extended line to the west ROW line of Spruce Street, and continuing along that line to its intersection with the north ROW line of East Second Street; then west along that line to the place of the beginning.

Councilman Bolton asked for the advantages. Mr. Garcia stated that it would put them in a better position to promote the Freeport Marina. Businesses that are active would be grandfathered.

There being no more comments from audience or council, Mayor Garcia closed the Joint Public hearing at 6:25 p.m.

Joint Public Hearing with the Planning Commission to consider a proposed amendment and to make a recommendation to the City Council concerning whether or not the Comprehensive Zoning Ordinance and Map of said City, codified as Chapter 155 of the Code of Ordinance of said City, should be amended to grant Ravin Patel a Specific Use Permit to operate a R/V Motor Recreation Site on Tract 6, Bridge Harbor Subdivision, within the corporate limits of said City.

Mayor Garcia opened the Joint Public Hearing at 6:25 p.m. to consider granting a Specific Use Permit to operate a R/V Motor Recreation Site on Tract 6, Bridge Harbor Subdivision, within the corporate limits of said City.

Edward Garcia stated to council that at this time, they could not make a recommendation because Mr. Patel had not complied with the Specific Use requirements.

Mr. Patel stated that he has lived in the area for 30 years and lives in Lake Jackson. He stated that he runs a good business and own condominiums at Bridge Harbor. He wants to invest in the city and operate a R/V Motor Recreation site if permitted. Hurricane Ike had done extensive damage to Bridge Harbor and they were still disputing damages with the insurance. He has spent \$37,000 on bathrooms.

Councilman Bolton stated that he had seen existing damage to Bridge Harbor. The docks had collapsed and needed attention. He wanted this done correctly and requested drawings and additional information.

Mayor Garcia had driven to Bridge Harbor and did concur with Councilman Bolton that Bridge Harbor was in dire need of attention.

Councilwoman Barbree said that Bridge Harbor was in her ward and would like him to get a permit for the R/V and get back to having a business.

Councilwoman Kent asked for the time frame in building the R/V. Mr. Patel answered 5 months.

John Cone an expert on real estate stated that it would devalue the property. It was not suitable for this location.

Tim Feldman owner of a condo unit # 115 feels the condos are not being operated correctly. He strongly opposes the R/V and feels it would be an eyesore. He mentioned that the Patel's owe \$15,000 to the Bridge Harbor Condo Association.

Debbie Collins leased from Mr. Patel but moved because of poor maintenance, swimming pool that was not in compliance. Her condo flooded, had plumbing problems, destroyed her furniture and they were suing her for moving out.

Sandra Krebs stated that she lives in unit 101 and maintenance is poor, unkempt grounds, swimming pool is not safe, no guards available, not a gated facility, tennis courts are deteriorating.

Judy Starnes in unit 103 stated that she had appeared before Council in 2003 and they had reassured her that it would not be zoned for a R/V nor a Specific User be granted.

Mingo Marquez stated that the Patel's had bought Bridge Harbor in 1992 and had been hit by several hurricanes. Their intention is to go after the tourists, attract people to this area, by building a resort type of business. Fuel prices are up and they were trying to survive.

Tobey Davenport agreed with Mr. Garcia that he is not for or against it, but more detail information is required before making a recommendation.

There being no more comments from audience or council, Mayor Norma Garcia closed the Joint Public Hearing at 7:00 p.m.

ORDINANCE NO. 2012-2311

AN ORDINANCE OF THE CITY OF FREEPORT, BRAZORIA COUNTY, TEXAS, CONTAINING A PREAMBLE; CONTAINING FINDINGS OF FACT AND CONCLUSIONS OF LAW; AMENDING THE COMPREHENSIVE ZONING ORDINANCE OF THE CITY, NOW CODIFIED AS CHAPTER 155 OF THE CODE OF ORDINANCES OF THE CITY, TO ADD TO SECTION 155.02 NEW DEFINITIONS OF MARINA. AND MARINA RELATED BUSINESS., TO ADD THERETO A NEW SECTION 155.048 ESTABLISHING A NEW ZONING DISTRICT AND CLASSIFICATION TO BE KNOWN AS W-4 MARINA DISTRICT, SPECIFYING THE BOUNDARY THEREOF AND PEROXIDING REGULATIONS THEREFOR, AND AMENDING SAID COMPREHENSIVE ZONING ORDINANCE TO CHANGE THE CURRENT CLASSIFICATION OF ALL PROPERTY LOCATED WITHIN THE BOUNDARY OF SUCH NEW DISTRICT FROM ITS PRESENT ZONING CLASSIFICATION TO SUCH NEW ZONING CLASSIFICATION OF W-4; RATIFYING AND CONFIRMING ALL ACTIONS PREVIOUSLY TAKEN BY THE PLANNING COMMISSION OF SAID CITY OR THE CITY COUNCIL, OR BOTH; PROVIDING THAT ANY PERSON VIOLATING SAID CODE OF ORDINANCES, AS AMENDED BY THIS ORDINANCE, SHALL BE GUILTY OF A MISDEMEANOR AND ASSESSED A FINE IN ACCORDANCE WITH THE PROVISIONS OF SECTION 155,999 OF SAID CODE OF ORDINANCE AND THAT EACH DAY ANY SUCH VIOLATION CONTINUES SHALL CONSTITUTE A SEPARATE OFFENSE: CONTAINING SAVINGS CLAUSES; CONTAINING A SEVERANCE CLAUSE; AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER THIS DESCRIPTIVE CAPTION HAS BEEN PUBLISHED TWICE IN THE BRAZOSPORT FACTS.

WHEREAS, the City of Freeport, Texas (whe City.), is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, Subchapter A of Chapter 211 of the Local Government Code of Texas and Item (g) of Section 3.07 of the Home Rule Charter of the City authorizes the City Council thereof to adopt the provisions of this Ordinance; and,

WHEREAS, the City Council of the City has determined to here now declare that it is necessary to the health, safety and general welfare of the inhabitants of the City for there to be established a new zoning classification to be known as W-4 Marina District, to specify the boundaries thereof and regulations therefor, and to change the zoning classifications of all land within such new zoning district from its present zoning classification to the new zoning classification of W-4 Marina District.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

SECTION ONE--Findings of Fact and Conclusions of Law.

he City Council of the City makes the following findings of fact and conclusions, viz:

First, that the public hearings required by the Zoning Enabling Act of the State of Texas, codified as Chapter 211 of the Texas Local Government Code, and the present Comprehensive Zoning Ordinance of the City, codified as Chapter 155 of the Code of Ordinances of the City, have been conducted in the manner and at the time required.

Second, that not less than fifteen (15) days prior to the date of such hearings, public notice thereof was published once in the Brazosport Facts, a newspaper of general circulation in and the official newspaper of the City, stating the date, time and place of such hearings.

Third, that after considering evidence submitted at such hearings, the City Council of the City is of the opinion and finds that the health, safety, morals and general welfare of the inhabitants of the City will best be served by the creation of the new zoning classification and district to be known as W-4 Marina District, within the boundaries and with the regulations hereinafter set forth.

Fourth, the conditions which warranted the classification of the property included within the boundaries hereinafter set forth at the time of such classification have substantially changed and conditions now exist which indicate that the present zoning classification of such property is no longer appropriate; and, Fifth, considering the community as a whole and the present Comprehensive Zoning Plan of the City, such property should be reclassified for purposes of zoning and the zoning of such property changed to W-4 Marina District.

Sixth, the health, safety, morals and general welfare of the inhabitants of the City will best be served by changing the zoning classification of all property located within such boundaries from the present zoning classification thereof to the new W-4 classification.

SECTION TWO--Comprehensive Zoning Ordinance Amended

The Comprehensive Zoning Ordinance of the City of Freeport, Texas, read, passed and approved as Ordinance No. 1100 on the 3rd day of April, 1964, now codified as Chapter 155 of the Code of Ordinances thereof and hereinafter called "the Zoning Ordinance," is hereby amended as follows:

First, Section 155.002 of the Code of Ordinances is amended to add, in its alphabetical sequence, the following definitions:

■MARINA. A dock or basin providing secure moorings for pleasure boats and often offering supplies, repair and other facilities.

■MARINA RELATED BUSINESS. Any business which primarily provides goods and services to any customer of any marina located in the W-4 Marina Zoning District.

Second, a new Section 155.048 is hereby added to the Code of Ordinance which would read as

follows:

SECTION 155.048-W-4 MARINA DISTRICT

This district includes all of the land within the City which is located within the following boundary:

Beginning at the intersection of the north ROW line of West Second Street, at its intersection with the east ROW line of Cherry Street; thence north to the northern ROW line of the Freeport Townsite Levee; thence east to the extension of the eastern property line of Tract 1A, Thomas McKinney Survey, Abstract 87, Brazoria County, Texas; thence north along that extended line to the centerline of the Old Brazos River Channel; thence along the center line of that Channel east to the extension of the western property line of Tract B1A, S.F. Austin Survey, Abstract 28, Brazoria County, Texas; thence south along that extended line to the west ROW line of Spruce Street, and continuing along that line to its intersection with the north ROW line of East Second Street; then west along that line to the place of beginning.

- (A) Minimum requirements for lot area, width and setback shall be the same as provided elsewhere within the zoning ordinance for the particular use or uses specified in the W-4 District.
- (B) See Section 155.023 for supplementary district regulations, exceptions and parking requirements applying to the W-4 District.
- (C) See section 155.060 (D) and (E) for temporary use permits that may be granted by the Board of Adjustments and specific use permits that may be recommended by the City Planning Commission within the W-4 District under certain circumstances and conditions
- (D) Permitted uses.

Any use permitted in R-1, R-2, R-2A, R-3, C-1, W-1 or W-1R, and

- (E) Parking Requirements and site plans as provided elsewhere in the zoning ordinance for the particular use or uses specified in W-4
- (F) Building Height- In Marina W-4 District, building height shall be allowed up to 100 ft., plus additional height of 1-ft. for every 4 ft. setback from yard line.

SECTION THREE--Ratification and Confirmation.

The City Council of the City of Freeport, Texas, hereby ratifies and confirms any and all action taken by the Planning Commission of said City or the City Council of said City, or both, in connection with the change in zoning classification evidenced by this ordinance, including but not limited to the calling of a public hearing required by said Zoning Enabling Act and the Zoning Ordinance, the giving of public notice of such hearings, the giving of written notice to the owners of property which is the subject of such and to the adjoining property owners, the making of preliminary and final reports with respect to such change and the conducting of the public hearings required by said Act and the Zoning Ordinance.

SECTION FOUR--Penalty

Any person violating the Zoning Ordinance, as amended by this ordinance, shall be guilty of a

misdemeanor and upon conviction therefor assessed a fine as prescribed in Section 155.999 of said ordinance; and each day such violation continues shall constitute a separate offense.

SECTION FIVE--Savings Clauses

- (a) Nothing contained in this ordinance shall cause any rights heretofore vested to be altered, affected or impaired in any way and all such rights may be hereafter enforced as if this ordinance had not been adopted.
- (b) This ordinance is cumulative of and in addition to all other ordinances of the City on the same subject and all such ordinances are hereby expressly saved from repeal. Provided, however, where this ordinance and another ordinance conflict or overlap, this ordinance shall prevail.
- (c) No offense committed and no fine, forfeiture or penalty incurred prior to the effective date of this ordinance is to be affected by the adoption of this ordinance but the punishment for any offense committed and the recovery of any fines or forfeitures incurred prior to such date shall take place as if this ordinance had not been adopted.

SECTION SIX--Severance Clause.

In the event any section or provision of this ordinance is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

SECTION FIVE--Effective Date.

This ordinance shall take effect and be in force from and after the descriptive caption of this ordinance has been published twice in the Brazosport Facts, the official newspaper of the City.

AN ORDINANCE OF THE CITY OF FREEPORT, TEXAS, CONTAINING A PREAMBLE; AMENDING CHAPTER 110 OF THE CODE OF ORDINANCES OF SAID CITY TO ADD A NEW SECTION 110.28 REQUIRING THE PROMINENT DISPLAY OF THE LICENSE REQUIRED BY SECTION 110.25 OF SAID CHAPTER; PROVIDING THAT ANY PERSON VIOLATING SAID CODE, AS AMENDED BY THIS ORDINANCE, SHALL BE GUILTY OF A MISDEMEANOR AND ASSESSED A FINE IN ACCORDANCE WITH THE PROVISIONS OF SECTION 10.99 OF SAID CODE OF ORDINANCES; PROVIDING THAT EACH DAY ANY SUCH VIOLATION CONTINUES AND EACH PART OF ANY DAY ANY SUCH VIOLATION OCCURS SHALL CONSTITUTE A SEPARATE OFFENSE; CONTAINING SAVINGS CLAUSES; CONTAINING A SEVERANCE CLAUSE; AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS DESCRIPTIVE CAPTION HAS BEEN PUBLISHED TWICE IN THE BRAZOSPORT FACTS.

WHEREAS, the City of Freeport, Texas, ("the City") is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, Sections 51.072, 54.001 and 54.004 of the Local Government Code of Texas, Chapter 105 of the Alcoholic Beverage Code of Texas and Section 2.01 and 2.02 of the Home Rule Charter of the City authorize the City Council thereof to adopt the provisions of this Ordinance; and,

WHEREAS, the City Council of the City has determined and do here now declare that the adoption of this ordinance is necessary to the health, safety and general welfare of the inhabitants of said City and the customers of persons required to obtain a license from the City by the provisions of said chapter.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

First, Chapter 110 of the Code of Ordinances of the City is hereby amended to add thereto a new Section 110.28, which shall read as follows:

Section 110.28 DISPLAY OF LICENSE

The license required by Section 110.25 shall be prominently displayed alongside the state required license or permit issued to a licensee or permittee selling alcoholic beverages within the city.

Second, any person violating the Code of Ordinances of the City of Freeport, Texas, as amended by this ordinance, shall be guilty of a misdemeanor and upon conviction therefor assessed a fine as prescribed in Section 10.99 of said Code; and each day such violation continues and each part of any day any such violation occurs shall constitute a separate offense.

Third, in the event any section or provision of this ordinance is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

Fourth, this ordinance shall take effect and be in force from and after the descriptive caption of this ordinance has been published twice in the Brazosport Facts, the official newspaper of the City.

WHEREAS, pursuant to the provisions of Subsection (a) of Section 102.007 of Chapter 102 of the Local Government Code and the provisions of Article 9 of the Home Rule Charter of the City of Freeport (hereinafter sometimes "the City"), the budget for the 2011-2012 fiscal year of the City was finally approved by the City Council, being the governing body thereof, by its Ordinance No. 2011-2286, read, passed and adopted on the 12th day of September, 2011, (hereinafter sometimes "the Budget"); and,

WHEREAS, Subsection (b) of Section 102.009 of the Local Government Code provides that, after final approval of the budget, the governing body of a municipality may spend municipal funds only in strict compliance with the budget, except in an emergency, but Section 102.010 of said Code provides that the provisions of Chapter 102 thereof do not prevent the governing body of such municipality from making changes in the budget for municipal purposes; and

WHEREAS, Subsection (c) of Section 102.009 of said Code provides that the governing body of a municipality may authorize an expenditure as an amendment to the original budget only in the case of grave public necessity to meet an unusual and unforeseen condition that could not have been included in the original budget through the use of reasonably diligent thought and attention; and,

WHEREAS, Section 9.16 of the City's Home Rule Charter provides that the budget may be amended and appropriations altered in accordance therewith in cases of public necessity, the actual fact of which shall have been declared by the City Council; and,

WHEREAS, the adoption of this ordinance and the amendment of the Budget is necessary for and in the best interest of the health, safety and general welfare of the inhabitants of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

SECTION ONE (1): FINDINGS OF FACT

In connection with the amendment and revision of the Budget, the City Council of the City makes the following findings:

- (1) The amendments and revisions set forth in the Budget were the result of numerous public workshop meetings called and conducted in the manner required by the Texas Open Meetings Act, codified as Chapter 551, Government Code.
- (2) A public hearing was held on the Budget on September 12, 2011, and conducted in the manner required by Section 102.006 of the Local Government Code and the City's Home Rule Charter.
- (3) Notice of such public hearing was published in the Brazosport Facts, a newspaper of general circulation in and the official newspaper of the City in the manner and time required by Chapter 102 of said Code and the City's Home Rule Charter.
- (4) A grave public necessity exists and to meet an unusual and unforeseen conditions that could not have been included in the original budget through the use of reasonably diligent thought and attention and the Budget must be amended and revised with respect of the new or additional expenditures set forth in Exhibit "A" attached hereto and made a part hereof, such unusual and unforeseen conditions also being set forth in said Exhibit "A".
- (5) The proposed changes are set forth in Exhibit "A" attached hereto and made a part hereof.
- (6) All of the changes set forth in Exhibit "A" are for municipal purposes.
- (7) The several amounts stated in Exhibit "A" as the amended or revised expenditures are hereby appropriated to and for the objects and purposes therein named.
- (8) The contingent appropriations, as amended and revised in said Exhibit "A", do not exceed three (3%) percent of the total amended and revised budget appropriations reflected therein.
- (9) The amended and revised expenditures of the general fund and the debt service fund contained in the Budget, as amended by said Exhibit "A", do not exceed the resources of each fund, as amended and revised.

AN ORDINANCE OF THE CITY OF FREEPORT, TEXAS, CONTAINING A PREAMBLE; CLOSING AND ABANDONING THE PUBLIC ROADWAY KNOWN AS THE SOUTH LEVEE ROAD FROM FM 1495 TO THE DEPARTMENT OF ENERGY BRYAN MOUND FACILITY; FINDING THAT SUCH CLOSING AND ABANDONMENT IS IN THE PUBLIC INTEREST AND THAT IT WILL BENEFIT THE PUBLIC; CONTAINING A SEVERANCE CLAUSE; AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND ADOPTION.

WHEREAS, there is located within the City of Freeport, Texas, hereinafter the City, a public road, known as the South Levee Road, running across Brazos River Harbor Navigation District Tracts 1, 1A, 2A, 4 and 5, from F.M. Highway 1495 to the Department of Energy Bryan Mound Facility; and,





DEMOLITION AGREEMENT

This Agreement for the demolition of the structure on Lot 12, Block 48, Velasco Townsite, City of Freeport, Brazoria County, Texas, by and between the CITY OF FREEPORT, TEXAS, a municipal corporation lying and situated in Brazoria County, Texas, hereinafter "the City", and the other undersigned, hereinafter called "the Demolisher" (whether one or more), viz.:

WITNESSETH:

- 1. All work will be completed in a good and workmanlike manner and according to the terms hereof and the specifications and bid document signed by or on behalf of the Demolisher and attached hereto.
- 2. § 90.44 TREATMENT AND CARE OF IMPOUNDED DOGS.

All dogs impounded under the provisions of this chapter shall, during confinement, be treated humanely and properly fed and cared for. An impounded dog which shall display symptoms of illness or disease or which is ferocious, vicious, or dangerous shall be kept separate and apart from all other impounded dogs.

§ 90.45 REDEMPTION OF IMPOUNDED DOGS.

The person entitled to the possession of a dog impounded under § 90.43, upon proper application within the specified time limits after the impounding of such dog, shall be entitled to have the impounded dog released to such person, provided such animal is not infected or thought to be infected with rabies, upon displaying proof of a current rabies vaccination, proof of a current license and payment of current pickup and shelter fees.

§ 90.46 REDEMPTION FEES.

Reasonable fees will be charged for the redemption of dogs impounded under § 90.43 and for all costs and services rendered by the Animal Control

Officer and the Southern Brazoria County Animal Shelter. The Animal Control Officer and the Southern Brazoria County Animal Shelter shall keep a current schedule of fees to be charged and such fees shall be approved by the City Council and the Board of Directors of the Southern Brazoria County Animal Shelter. All fees and monies for pickup and daily fees will be collected by the Southern Brazoria County Animal Shelter and are to be used to defray operational costs of the Southern Brazoria County Animal Shelter facility.

§ 90.47 OWNER LIABILITY FOR COSTS.

Every owner of any dog impounded, whether by the city or voluntarily by the owner, shall be liable for all costs and fees incurred by such impoundment. ('68 Code, § 6-96) Penalty, see § 10.99

§ 90.48 LIMITATION ON NUMBER OF DOGS.

- (A) **RESIDENTIAL PREMISES** means any premises improved with a structure which is used, in whole or in part, as a dwelling; and **HAVING CONTROL** of a premises means that the utilities furnished to such premises by the city are in the name of such person in the utility records of the city or the ownership of such premises is listed on the current tax roll of the city in the name of such person.
- (B) It shall be unlawful for any person having control of any residential premises in the city to keep, possess, harbor, or allow to remain upon such premises more than three dogs.
