# Call to Order.

Mayor Norma Garcia called the meeting to order at 6:00 p.m.

# Invocation.

Wallace Shaw offered the invocation.

# Pledge of Allegiance.

Mayor Norma Garcia led the Pledge of Allegiance.

Consideration of approving the August 1st, 2011 Council Minutes.

On a motion by Councilwoman Kent, seconded by Councilwoman Mireles, with all present voting "aye", Council unanimously approved the August 1st, 2011 Council Minutes.

# Attending citizens and their business.

Joyce Adkins reported that a coolant unit was donated to the animal control vehicle to keep the dogs cool during transportation.

Casares noticed the rehabilitation of streets in the city. It is his opinion that lowering the elevation of streets is not a good idea. Not everybody can evacuate during heavy rains when streets are flooded. A workable plan needs to be implemented. He reported the concrete on 4th Street in front of the Freeport Junior High School, off Highway 288 is deteriorating.

Brenda Laird thanked Chief Morrow for making our schools safe.

Consideration of authorizing the City Manager to implement a Drought Response Stage 2.

Jeff Pynes announced stage 2 of its drought contingency and water conservation plan. A 20% reduction in daily water allocation has been requested from the Brazosport Water Authority. Mr. Pynes read out water use restrictions to all residents and businesses. Notices of the restrictions will be enclosed with water bills to all residents of the City.

Mayor Norma Garcia asked how many water leaks were reported. Jerry Meeks of Veolia Water said 160 repairs as of this date, approximately 20-25 repairs of water leaks are pending.

Councilwoman Mireles noticed orange cones throughout the city and asked what they signified. Mr. Meeks stated that it was noted for repairs.

Annette Sanford commended Veolia Water for repairing the water leaks in the City.

On a motion by Councilwoman Kent, seconded by Councilwoman Barbree, with all present voting "aye", Council unanimously approved the City Manager to implement a Drought Response Stage 2.

Public Hearing to consider the adoption of an ordinance nominating both The Dow Chemical Plant A Project and The Dow Chemical Oyster Creek Project, both of which are located within the extraterritorial jurisdiction of the city, for triple enterprise project status under the provisions of the Texas Enterprise Zone Act, Chapter 2303, Texas Government Code (the Act").

Mayor Norma Garcia opened the Public Hearing at 6:15 p.m.

Chaney Moore from The Dow Chemical Plant informed Council that the program allows for a refund of State sales tax if the Dow Chemical Company meets certain capital spending and job retention criteria. The program requires that a project be nominated by a local city or county. Dow is applying for project status in both its Oyster Creek Division and Plant A. The program requires that a certain percentage of new employees be residents of a state enterprise zone or economically disadvantaged. If Dow does not meet this requirement, Dow will not receive refunds for those jobs.

Glen Jones asked why an ordinance was needed. Mr. Moore responded that it had to be a nomination from a local entity.

There being no more comments or questions from staff or audience, Mayor Norma Garcia closed the Public Hearing at 6:20 p.m.

# Public Hearing on the need to adopt an ordinance regulating the restraining of dogs.

Mayor Norma Garcia opened the Public Hearing at 6:22 p.m.

Chief Morrow stated that it was in the best interest of the City to adopt an anti-tethering ordinance. Their Animal Control Officers are seeing a lot of dogs chained in the city. A practice that leads to animal cruelty. Starting with an education period to pet owners then strict enforcement.

The City Secretary submitted 12 names to Council in support of the anti-tethering ordinance.

Pamela Dancy is an animal lover and favors the anti-tethering ordinances. There are dog owners that do not have their dogs updated on their vaccinations. Pet owners that do not walk their dogs; dogs that do not have food or water while they are chained. It is her opinion that if you can't afford a fence, you shouldn't own a pet.

Annette Sanford favors the anti-tethering ordinance.

Louie Jones favors the anti-tethering ordinance. He asked Council to revisit the front yard fencing ordinances. He stated that some dogs are chained because owners can not build a front yard fence.

Councilwoman Kent stated that she was a member of the Planning Commission some years ago and remembers the committee having lots of conversation and debates on the fencing ordinance.

Jim Pirrung stated that there is a way to chain an animal without getting tangled; a large screw into the ground with a rope or chain, given enough length to have excess to water and food.

Dan Tarver favors the anti-tethering ordinance. He asked Council to be the first city in Brazoria County to adopt an anti-tethering ordinance. He also asked Council to revisit the front yard fencing.

Barbara Crook lives on 9<sup>th</sup> Street, favors the anti-tethering ordinance. She has fed and watered other people's dogs.

Councilman Bolton wants to be certain that the proposed ordinance not have conflicts with the state requirements.

Joyce Adkins stated that she had no copy of the proposed ordinance.

There being no more comments from staff or audience, Mayor Norma Garcia closed the public hearing at 6:45 p.m.

Mayor Norma Garcia called the budget workshop to order at 6:10 p.m.

# Invocation.

Chief of Police Ty Morrow offered the invocation.

# Pledge of Allegiance.

Mayor Norma Garcia led the Pledge of Allegiance.

# Work Session:

• Budget Workshop for fiscal year 2011-2012.

Mr. Pynes reviewed the amendments and recommendations requested by council for fiscal year 2011-2012 budget. He presented a PowerPoint presentation for each department, points of the budget including the deductions and additions requested. The proposed budget is 1% less than last year. Mr. Pynes proposes lowering the tax rate from 0.708266 to 0.688053. Total budget expenditures of \$16,222,306 for fiscal year 2011-2012. Proposes a rental and rate increase on the city's four facilities, raising the recreational membership fee and charging a \$10.00 beach permit fee.

Mayor Norma Garcia asked for a breakdown of traffic and crime analysis and a list of city employees and salaries. She asked how much was generated from the water bills for ambulance service. Mr. Welch said \$80,000.

Joyce Adkins asked if a properly equipped vehicle was being considered for the animal control officers. Mr. Pynes said the animal control officer had a vehicle already.

Councilman Bolton asked about the warranty on the street sweeper since it was purchased on a lease option. Councilwoman Kent asked if there was a penalty for paying early.

Mayor Norma Garcia asked for the janitorial contract be reviewed and possibly rebidded. She asked about the grant to the Central Lift Station. Mr. Pynes said the grant had been awarded and we had an engineer and grant coordinator on this project.

Councilman Bolton asked how our salaries schedule compared to other similar cities. Mr. Pynes stated that we get our salary survey from Texas Municipal League.

Mr. Pynes showed a presentation of a camera-video that goes underground to evaluate the pipe infrastructure, showing pictures of tree limbs, cracks, defects, and branches. The cost of the camera is \$160,000. Mr. Pynes advises that a grant of \$200,000 had just been awarded to the City for pipe infrastructure and felt this type of equipment might fall under this grant.

Councilman Bolton was in favor of the projections. A good sound budget.

Mayor Norma Garcia closed the Budget Workshop Session and opened the Executive Session 7:10 p.m.





# VISION FOR THE MARINA DISTRICT

# Vision for the Marina District

The Marina District: The Downtown, Marina and Waterfront properties; represent the nucleus growth center for Freeport, as a place for people to live, shop, work and play. A managed growth in the Marina District with a small-town charm will reflect the City's rich history and invites new businesses, development, shoppers and residents. Mixed services in the District will encourage residents to shop locally and serve as a destination for visitors. Design guidelines and Land Use regulations shall be critical for this region to preserve and celebrate the City's unique location and maritime heritage.





# Existing Zoning Categories in the Marina Area

# West Quadrant/C-2 (Cherry to Navigation)

C-2 District, General Commercial
 Suitable for retail and wholesale activities- particularly, commercial uses that are not appropriate for Retail Business District. This District will permit almost any type of land use.


# Central Quadrant/W-2 (Navigation to Poplar)

✓ W-2 District, Waterfront- Light
Supports wide range of retail and wholesale activities relating to port, harbor or marine activities including manufacture, storage, transport and handling of goods as well as commercial.

# East Quadrant/M-1 (Poplar to Terminal)

M-1 District, Light Manufacturing
Fitted for commercial and industrial activities subject to limitations to protect nearby residential districts from nuisance.

WHEREAS, the City provides utility services to the residents of the City;

- Section 2. That the City commits \$157,829.00 in cash local funds from the Utility Fund towards this project; and,
- Section 3. That the City commits \$189,101.00 in cash local funds from the Brazoria County Urban Entitlement Community Development Program Utility Fund towards this project; and,
- Section 4. That these funds shall be used for sewer construction and engineering services.

Based on the limited details provided on the sign drawings, I can only conclude that, the "Sign Concept" looks OK. However, to gain full approval, the following issues have to be addressed:

- 1) The Total Sign Area = 140-sq.ft, in the denominations of 10'x10' and 4'x10' standing on a 30-ft high pole above grade.
  - a. Maximum allowable sign area = 66-sq.ft.
  - b. Maximum allowable sign height = 35ft; Proposed is 30-ft (OK)


Since the proposed sign area (140-sq.ft) is greater than allowable area (66-sq.ft), then, Variance via City Council will be required.

- 2) The City of Freeport is in a windstorm zone of 120-mph, at 3s gus. Wind load; Therefore, proof of compliance will be required.
  - a. Engineered drawings with P.E. seal affixed will be considered as complying.
  - b. Wind load calculations for sizing the support pole (reactions) for the signs are also required on the drawings.
- 3) The use of Light Emitting Diodes (LED) and Neon Lighting on the Pole or Fascia Signs will also require City Council approval.

I have copied D & A Signs (<u>dnasigns@yahoo.com</u>) on the above summary review. The representative that I spoke to promised to furnish the required engineered drawings. I have also copied the Building Codes/City Secretary to put the above Variance request on the next City Council Agenda.


