Ordinance No. 2012-2027

AN ORDINANCE OF THE CITY OF FREEPORT, TEXAS PERTAINING TO THE BRAZORIA COUNTY EROSION RESPONSE PLAN; AMENDING ORDINANCE NO. 2010-2263 THE DUNE PROTECTION AND BEACH ACCESS PLAN OF THE CITY OF FREEPORT, TEXAS, TO ADOPT REVISION 1 OF THE BRAZORIA COUNTY EROSION RESPONSE PLAN.

WHEREAS: The Erosion Response Plan (ERP) was developed by Coast & Harbor Engineering, Inc. under Brazoria County Contract No. 11-022-000-4320, pursuant to the authority granted by Texas Natural Resources Code, 33.607 for reducing public expenditures for erosion and storm damage losses to public and private property, including public beaches in consultation with the Texas General Land Office.

WHEREAS: The City of Freeport is recognized as holding a governmental jurisdiction located on the southwest side of the Freeport Channel within Brazoria County with an average long-term erosion rate for the shoreline for the City of Freeport is 8 to 19 ft/yr and the majority of erosion rates are over 10 ft/yr.

WHEREAS: Brazoria County and local governments have established a Dune Protection Line (DPL) for the purpose of protecting critical dune areas. This line runs parallel and adjacent to the Gulf of Mexico. The City of Freeport has a Dune Protection Line (DPL) of 1,000 ft. landward of the Mean Higher High Water (MHHW) between the northeasterly right of way F.M. Highway 1495 and the bank of the Brazos River Diversion Channel.

WHEREAS: The City of Freeport proposed no Variance of Construction Requirements for Exempt Properties at the time of submission of this draft.

WHEREAS: The City of Freeport has two vehicular access points which are in good condition and allow for easy driving onto the beach. These access points do not need any improvements at the present time, however; suggested improvements would be to increase Beach Access No. 1 elevation by 4 feet at the dune location and add additional limestone base to Beach Access No. 2 subject to available funding.

NOW, THEREFORE, BE IT ORDAINED that, after discussion, the City Council of the City of Freeport, Texas, has accepted Revision I of the Brazoria County Erosion Response Plan that was submitted to Brazoria County and its Cities on April 16th, 2012, and the Dune Protection and Beach Access Plan of the City of Freeport, heretofore adopted as Ordinance 2010-2263, is hereby amended to add the County's Revision I to the City's Plan.

Houston-Galveston Area Council Regional Hazard Mitigation Plan – 2011 Update Overview, Adoption Requirements and Frequently Asked Questions

Overview: The Disaster Mitigation Act of 2000 makes the development of a hazard mitigation plan a specific eligibility requirement for any local government applying for FEMA mitigation-grant funding, specifically the Hazard Mitigation Grant Program (HMGP) and Pre-Disaster Mitigation (PDM) Program. Your municipality or county participated in the development of the original plan in 2006. During 2010, the Houston-Galveston Area Council received funding from the Texas Division of Emergency Management (DEM) to update its existing regional hazard mitigation plan. H-GAC worked with 77 local governments, including the emergency management coordinators of seven counties and some cities, to update the plan that identifies regional hazards, vulnerabilities, local capabilities, and locally-specific projects designed to mitigate damages associated with future disasters. Once final approval is granted by FEMA, the governments included in the plan are eligible to receive FEMA funding for their projects.

Adoption Requirements: Adoption of the plan at the local level is required before FEMA will grant final approval of the plan. Each participating community is required to adopt the plan by resolution or other formal mechanism. The adoption process includes holding a public hearing to allow local citizens an opportunity to voice opinions and make comments regarding the plan. Most communities hold the public hearing on the same day as the city council or county meeting held to adopt the plan. Each community follows its standard process for posting the public notice. Once the plan is adopted, a copy of the signed resolution is faxed, emailed or mailed to Amy Boyers at H-GAC. Fax: 713-993-4503, Email:

Thy.Powers at in Cacacom, Mail: PO Box 22777, Houston, TX 77227-2777. We are asking that plan participants adopt the plan during September and November, 2012 — and no later than November 16, 2012, in order for H-GAC to submit copies of local resolutions to FEMA and meet our grant deadline.

Frequently Asked Questions:

O: What will happen if my community fails to adopt the plan before November 16, 2012?

A: The community will not be included in H-GAC's submittal of resolutions, and will have to wait until FEMA allows H-GAC to update the plan and add participants and new projects. The community will not have an approved plan in place and will not be eligible for FEMA mitigation-grant funding under the HMGP and PDM programs.

Q: Why do I need to adopt the plan now if I adopted it in 2006?

A: The 2006 regional hazard mitigation plan expired in April 2011. Participating jurisdictions must adopt the 2011 plan update in order to be eligible for HMGP and PDM funding.

Q: What changes were made to the plan between 2006 and 2011?

A: The 2011 plan update includes an analysis of recent repetitive loss data associated with flooding, expansion of wildfire assessment, inclusion of available 2010 Census data, updated local jurisdiction capability assessments and 358 additional local mitigation actions (bringing the total number to 852.) The natural hazards of tsunamis, earthquakes, sinkholes and subsidence were removed from the update, and per FEMA's requirements, expansive soils as a hazard was added.

Q: My community has several mitigation actions in the plan. If we adopt the plan, are we required to carry out those projects?

A: No. By adopting the plan, communities are not committing to carrying out their mitigation actions. By adopting the plan, your community becomes eligible to apply for those mitigation actions when PDM and HMGP funding becomes available.

RESOLUTION NO. <u>2012</u> -2400

A RESOLUTION OF THE CITY OF FREEPORT, TEXAS, CONTAINING A PREAMBLE; MAKING FINDINGS OF FACT; ADOPTING THE HOUSTON-GALVESTON AREA COUNCIL-REGIONAL HAZARD MITIGATION PLAN 2011 UPDATE; VESTING THE CITY EMERGENCY MANAGEMENT COORDINATOR WITH CERTAIN RESPONSIBILITIES, AUTHORITY, AND MEANS WITH RESPECT THERETO; REQUIRING SUCH COORDINATOR TO REVIEW SUCH PLAN ANNUALLY AND PRESENT ANY NEEDED CHANGES OR ADDITIONS THERETO TO THE CITY COUNCIL FOR ITS CONSIDERATION; AND TAKE SUCH OTHER OFFICIAL ACTIONS AS MAY BE REASONABLY NECESSARY TO CARRY OUT THE OBJECTIVES OF SUCH PLAN; CONTAINING A SEVERANCE CLAUSE; PROVIDING THAT THIS RESOLUTION SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND ADOPTION; AND PROVIDING THAT THE ORIGINAL OF THIS RESOLUTION SHALL BE MAINTAINED BY THE CITY SECRETARY IN THE PERMANENT RECORDS OF SAID CITY.

WHEREAS, the City of Freeport, Texas, hereinafter sometimes "the City," is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, certain areas of the CITY OF FREEPORT are subject to periodic flooding and other natural hazards with the potential to cause damages to people properties within the area; and

WHEREAS, the CITY OF FREEPORT desires to prepare and mitigate for such circumstances; and

WHEREAS, under the Disaster Mitigation Act of 2000, the United States Federal Emergency Management Agency (FEMA) requires that local jurisdictions have in place a FEMA-approved Hazard Mitigation Action Plan as a condition of receipt of certain future Federal mitigation funding after November 1, 2004; and

WHEREAS, the cities and counties in the H-GAC Region, in order to meet this requirement, have initiated development of a regional, multi-jurisdictional Hazard Mitigation Plan, including the CITY OF FREEPORT;

WHEREAS, the City Council of the City has determined and do here now declare that the adoption of this resolution is necessary to the health, safety and general welfare of the inhabitants of the City and persons sojourning therein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

First, the City Council of the City of Freeport, Texas, makes the following findings of fact:

Second, adopts the Houston-Galveston Area Council - Regional Hazard Mitigation

Plan = 2011 Update.

Third, vests the City Emergency Management Coordinator with the responsibility, authority, and the means to:

- (a) Inform all concerned parties of this action.
- (b) Develop an addendum to this Hazard Mitigation Plan 2011 Update if H-GAC•s, a city•s, a county•s or a district•s unique situation warrants such an addendum.

Fourth, appoints the City Emergency Management Coordinator to assure that the Hazard Mitigation Plan = 2011 Update be reviewed at least annually and that any needed adjustment to the CITY OF FREEPORT addendum to the Hazard Mitigation Plan = 2011 Update be developed and presented to the CITY COUNCIL for consideration.

Fifth, agrees to take such other official action as may be reasonably necessary to carry out the objectives of the Hazard Mitigation Plan 2011 Update.

Sixth, in the event any section or provision of this resolution is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

Seventh, this resolution shall take effect and be in force from and after its passage and adoption.

Eighth, the original of this resolution, after execution and attestation, shall be maintained by the City Secretary in the permanent records of the City.

On July 12, 2012 bids were received for the City of Freeport Central Lift Station Rehabilitation. Four (4) bids were received with a low bid of \$842,290.80 being received from L.L. & F. Construction Management, Inc. of El Campo, Texas. The second low bid was only \$7,037.25 or less than 1% above the low bid. While the low bid is over the amount of construction funds currently available in the project budget, it is my recommendation that the City set aside sufficient funds in the next fiscal year budget to complete funding for the project. Attached is a table showing the additional funding amount that will be required to totally fund the Project.

I am familiar with the contractor and have no hesitation in recommending that L.L. & F. Construction Management, Inc. be awarded the project of construction for the City of Freeport Central Lift Station Rehabilitation project.




