Call to Order.

Mayor McDonald called the meeting to order at 6:00 p.m.

Invocation.

Wallace Shaw offered the invocation.

Pledge of Allegiance.

Mayor McDonald led the Pledge of Allegiance.

Consideration of approving the April 18th, 2011 Council Minutes.

On a motion by Councilwoman Garcia, seconded by Councilwoman Kent, with all present voting "aye", Council unanimously approved the April 18th, 2011 Council Minutes.

Attending citizens and their business.

John Stanford addressed Council on violations of the City's Charter and spending issues. He read out Section 5.08 Oath of Office to the Council; reminded Council that they are bound by the Oath of Office to enforce the oath as it indicates. He also stated Section 4.01 of the Charter stipulates that the City Manager should be a resident in the City. He understands that the City Manager is living in Houston, Texas which is a violation of the Home Rule Charter and believes that this needs to be dealt with. He spoke on Section 5.14 Audit and Examination of City Books and Accounts. He requested a copy of the auditor's report through Open Records Act dated June 2nd 2010, latest audit conducted in the City of Freeport. So the city has gone over 8 months without an audit being conducted. He said that Section 5.14 mandates that an audit be done as soon as possible after the close of the fiscal year, and is required to have two (2) spot audits unannounced during the fiscal year, as of now 7 months later, no audits reports. This was a Charter violation. He stated that the City requires a bond disclosure by the end of March and without an audit, you cannot have a bond disclosure so this could have a detrimental effect on our bond ratings. He asked Council to look at these issues. Last year he addressed Council on the purchase of two office chairs, in the City's attempt to block that information through the Attorney General office for expenditures of approximately \$4,700. He reminded the Mayor that in previous open meetings, he was told that he would look into this matter. He asked the Mayor if he had looked into this, done anything or if he was going to ignored it or what exactly had he done about it. Mayor McDonald replied "yes" I have. Mr. Stanford asked: Are you going to let us know, what is it? Mayor McDonald said "I could, yes sir I will get back with you". I just found out that the City recently purchased 2 IPads at a cost of \$795.00 each. A ridiculous wasteful of tax dollars when we can't even afford to give our city employees a cost of living increase. I think we need to set our priority straight which is more important; \$1,600 is not going to break the bank but when we see this frivolous spending with employees going on without a cost of living increase, it's just not right.

Manning Rollerson said it was a shame that a man had to call the whole community to show up at a store because he wanted to turn himself in but was afraid the police might shoot him. He also reported a big break in the street on North Ave. J. Mr. Manning was upset that some of his political signs were removed and had been advised to file criminal mischief on the person responsible. He stated that he wanted to run a fair campaign.
