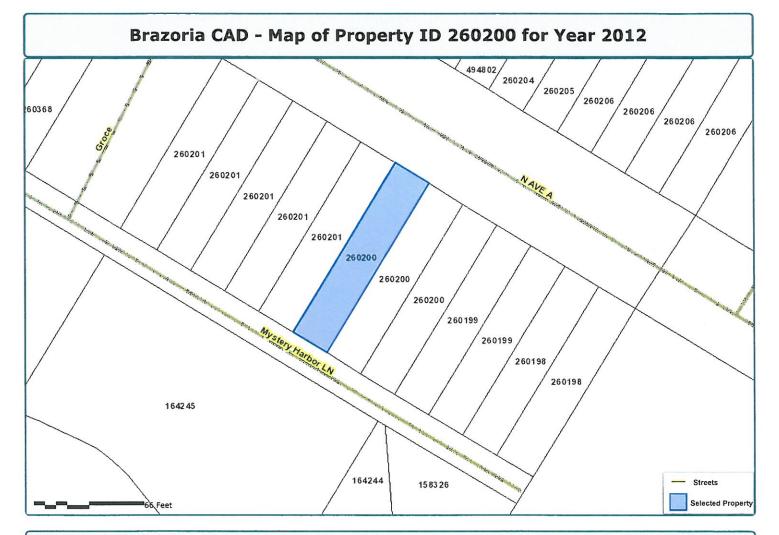
### <u>Discuss/consider limiting the square footage of building space that may be utilized as a residence in</u> a commercially zoned district.
